Oriental Petroleum & Minerals Corporation (OPMC) wishes to advise that the Department of Energy (DOE) has terminated the Farm In Agreement between Pitkin Petroleum Plc. (PITKIN) and the SC-14C2 West Linapacan Farmors involving 58.29075% participating interest.

Pitkin Petroleum Plc subsequently farmed out half or 29.145375% to RMA West Linapacan Pte Ltd (RMA).

In the letter of the DOE dated 12 March 2015 the farmed out interest to PITKIN and RMA from the Farmors, which include among others OPMC and Linapacan Oil Gas & Power Corporation (LOGPOCOR), have reverted back to the Farmors.

With the return of the farmed out interests, OPMC will go back to its original interest of 19.8600% and LOGPOCOR to 10.4280%.
